<u>Conlin on transportation</u> Seattle gets four months to work on SR520 west side interchange; no special tax for seawall

The biggest problem with the replacement of SR520 is the west side interchange, Seattle City Council President Richard Conlin told the Metropolitan Democratic Club of Seattle at its regular March 10 meeting. Therefore construction will begin on the east side to give Seattle four more months to work on it.

SR520 is the key east-west connector with 110,000 users per day, Mr Conlin noted, and the design of the its replacement is the decision of the Washington State Department of Transportation. The preferred design option, he said, is "A+," which calls for four lanes plus two for transit and high occupancy vehicles, and includes the capability of adding rail transit. It also contemplates a second bascule bridge adjacent to the existing Montlake Bridge.

Most of the city council is unhappy with the "A+" option Mr Conlin emphasized, because they say it doesn't work for the neighborhood. The city has hired a consultant to assist with the design of the west side configuration. He added that Mayor Michael McGinn wants to see rapid transit or dedicated bus lanes as part of the design.

The SR99 tunnel, another WSDOT project, is going forward, Mr Conlin announced, although with respect to the seawall, funding will have to come from the city. The mayor's

Bagshaw, O'Brien describe first three months in office

They both indicated that they like their jobs very much, although Mr O'Brien admitted that he hasn't quite figured everything out yet.

proposal for a special tax will not be on the ballot in May, he said.

Asked about the relationship between the council and the mayor, Mr Conlin replied that the council is still working through a "shake-down period" but is pleased that Mr McGinn is much more open and that councilmembers have more access to city departments.

Committee, serves as vice chair of the Regional and Sustainable Development Committee and serves on the Finance and Budget Committee. In addition to his committee work he intends to work towards a carbon neutral Seattle, empowering communities to get involved in government, and racial and social justice.

Asked if Councilmember Tim Burgess's proposed panhandling law would interfere with civil liberties, Ms Bagshaw, who admitted she supports the legislation, said it misses the big picture because there is funding to put more cops downtown, to deal with mental health problems and fund other services. Mr O'Brien replied that he did not think the legislation will be an effective way to address the problem, but said it does indicate that the council is concerned about the objectionable behavior. The emphasis, he said, should be on funding.

The two councilmembers also addressed questions about SR520, the selection of the new chief of police, neighborhood issues and underserved communities.



Executive committee formalizes process of electing board members

The executive committee has decided to formalize the process by which board members are elected for twoyear staggered terms as required by the MDC bylaws. Therefore it is requesting that those who wish to serve on the MDC board for the 2010 -2012 term submit their names to Eleanor Munro by April 28. These will appear on a ballot to be included in the May newsletter. The mailed ballots will be due shortly before the annual meeting, when the results will be announced. Members can also bring their ballots to the meeting to be counted.

The names of those currently serving on the board have been alphabetized and numbered. Those whose names are odd numbered are up for election this year; those whose names are even numbered are up for election next year for the 2011-2013 term. This year those who are up for election are Jean Arnott, Nelson Dahl, Carole Glickfeld, Lem Howell, Roger Leed, Mark Marshall, Allan Munro, Al Rasmussen, Cleve Stockmeyer, Janet Thompson, and Michael Weisman. These names will appear on the ballot only at the request of the board member

Other members who wish to serve on the board may submit their names as well. There is no limit to the number of candidates who can compete for board membership. The bylaws allow a maximum of 29 board members. Members may vote for any number of candidates not to exceed 15 this year and 14 next year. Any candidate receiving a simple majority of the total number of votes earns a place on the board.

The reason for instituting this process is that in the recent past

board members have been elected in an informal voice vote at the annual meeting without anyone knowing who has served two years and without knowing whether only eligible members are voting. This will allow us to keep track of the staggered terms required by the bylaws and ensure that eligible members are the only ones who vote.

Those who submit their names for election may also submit a statement of no more than 50 words, which will also appear in the ballot for the convenience of the voting members. Names can be submitted by mail, email (walkere1@msn.com) or telephone, 206-937-9825.

a list of all those elected officials up for office this year, declared candidates, and initiatives. book review The Breakthrough: Politics and Race in the Age of Obama

This 245-page book is a sweeping summary of changes through the past 60 years, of the race-gender conflict and of the question of being "black enough" versus being "too black."

Ifill is a journalist, both print and TV, moderator and managing editor of Washington Week and senior correspondent on The News Hour With Jim Leher.

In Gallup polls, in 1958 more than half of Americans said they would not vote for a black candidate, by 1984 only 16 percent and by 2007 in a Newsweek poll only 4 percent. Obama got 43 percent of the white vote, compared with 41 percent by Kerry. There is a long chapter on how he finessed the race issue.

In the early 1990s polling began documenting a generational divide among black Americans: "a quarter described themselves as conservative, nearly a third as moderates, 48 percent as liberal." Blacks born in 1960s and 1970s "lived in a world shaped by access instead of denial." Those "who marched then often turn out to be the biggest critics of those who are poised to take over now."

Several case studies illustrate the generational transition, most notably the conflict between Jesse Sr. and Jesse Jr. in Illinois. While the father "thinks back to the arc of a movement that started in the 1950s, the son is more

focused on saving black folks from the sins of their fathers." Jesse Jr. said, "There is a place for the agitation and protest politics of a Jesse Jackson, Sr., and an Al Sharpton, but it is not here. Not now."

Individual short chapters detail the smoother transitions between the Fords in Tennessee, the Patersons in New York, the Clays in Missouri, the Mallorys in Ohio, the Meeks in Florida.

"Aspiring black leaders are often commanded to transcend race, even though no one ever asked, say, Hillary Clinton to transcend gender." Shirley Chisholm, who in 1970 had both race and sex hurdles, maintained that sex was the more difficult one. Carol Moseley Braun concurred, as did Baltimore mayor Sheila Dixon, and speaker of California Assembly Karen Bass.

comfortable with black candidates who do not seem (to harbor) anger, while blacks are often more suspicious."

Massachusetts Governor Deval Patrick said, "You can't be black enough if you speak the King's English." Nader called Obama an Uncle Tom for trying to "talk white." Kendrick, (US Rep FL) said blacks "want to know that the people they elect -- with their Ivy League degrees and new power -- have not forgotten their roots." Separate chapters dissect this tension in the case of Patrick and of Newark Mayor Corey Booker.

The writing is superb: several characters -- some unknown to this reviewer -come alive on the page.
